## Renewal of Membership

Subscriptions for 2012 are due for renewal on 1 January. This reminder is being sent to all members; if you are a life member or your subscription renewal is paid automatically by banker's order (automatic withdrawal), you may safely ignore it. Otherwise, we should like to encourage you to arrange for payment by such means (and if you are a UK tax payer to sign a Gift Aid form as well). You may request the appropriate forms in the order form below, or you may renew online ([www.athosfriends.org/membership](http://www.athosfriends.org/membership)), where the appropriate forms are also available as well as further information for UK taxpayers about the Gift Aid scheme.

Rates are unchanged from last year, but costs continue to increase and additional donations would be most welcome.

The minimum rates for life membership are £250, \$400, or €330 (or half these figures for those over 65). If you would like to become a life member, please indicate accordingly on the form below, and note whether you would like a Gift Aid form.

You may of course continue to subscribe on a yearly basis and UK taxpayers may make such payments also under the Gift Aid scheme. The minimum rates are £25 for institutions and communities, £15 for individuals, and a reduced rate of £7.50 for students, pensioners, monastics, and the unwaged. Dollar and euro rates are shown on the attached form.
